

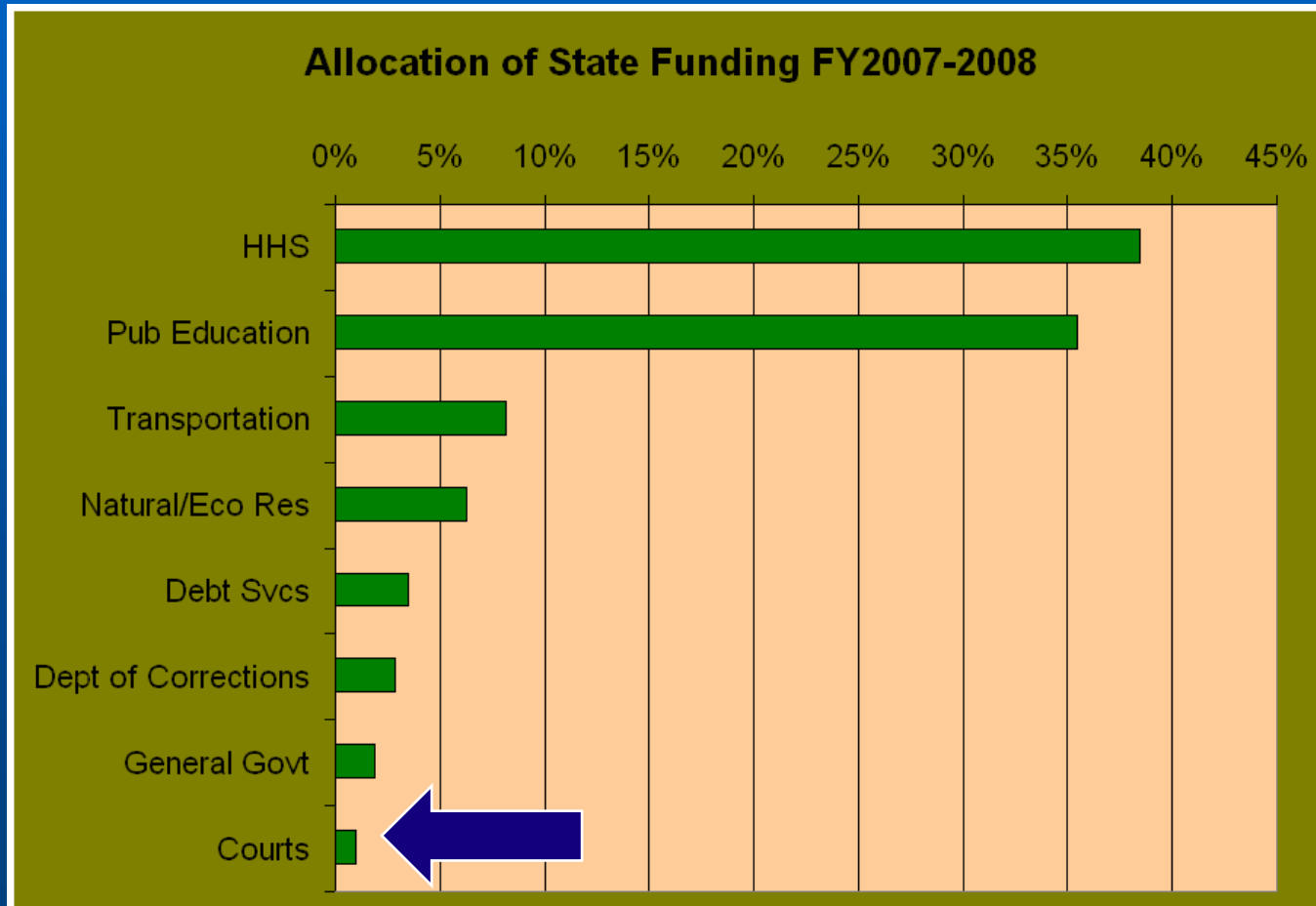

Mecklenburg County logs approximately 18% of the Violent Crime Index and approximately 15% of the Property Crime Index in the state (2007)

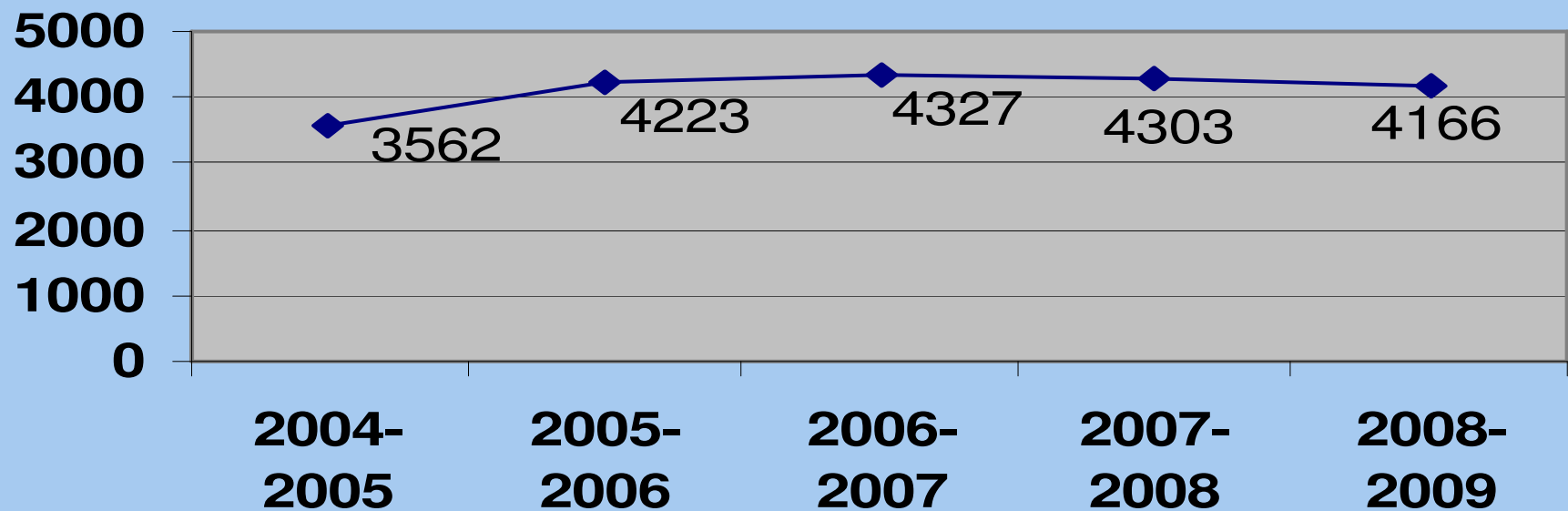

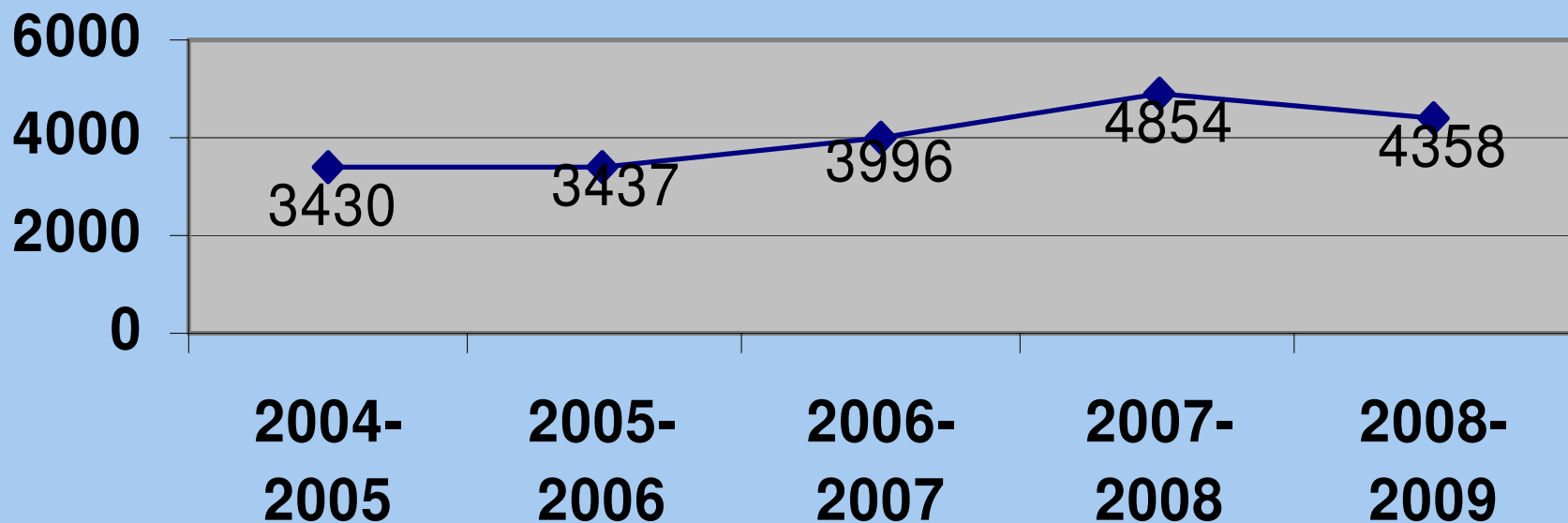

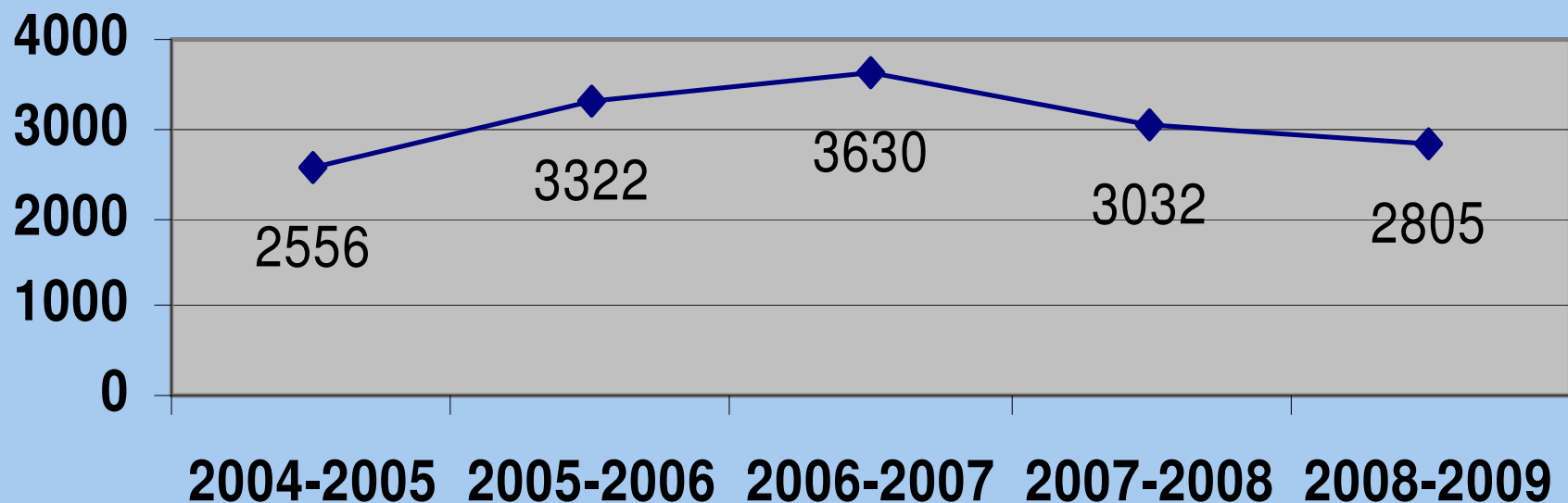

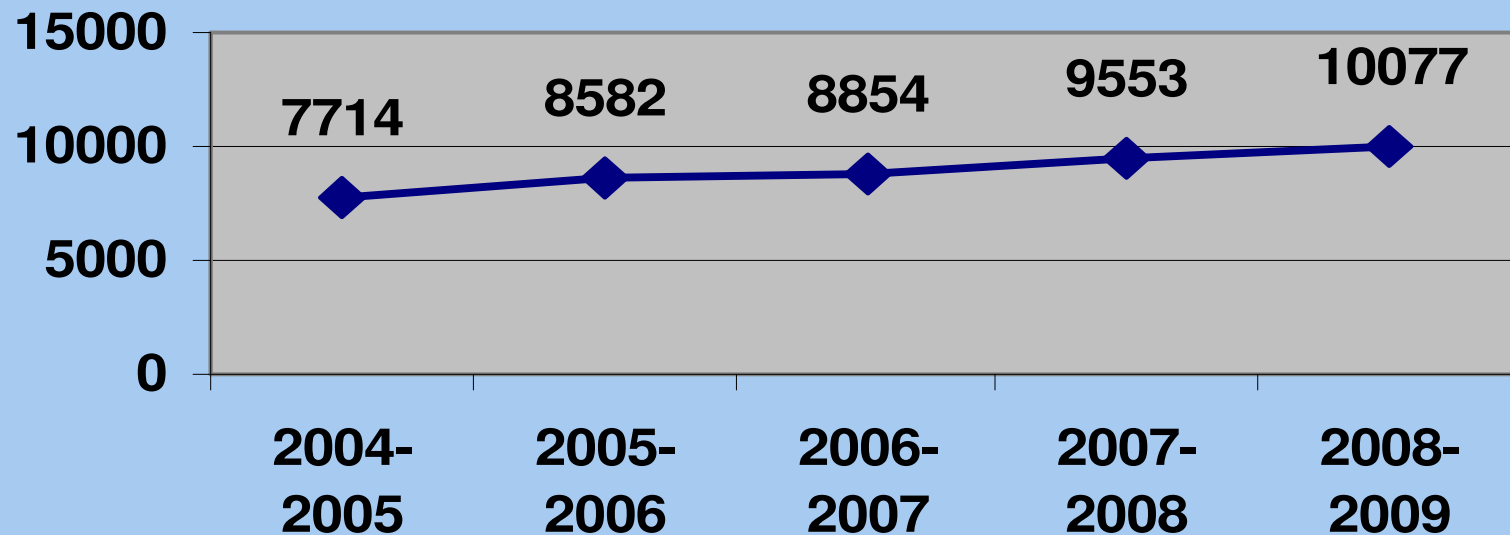

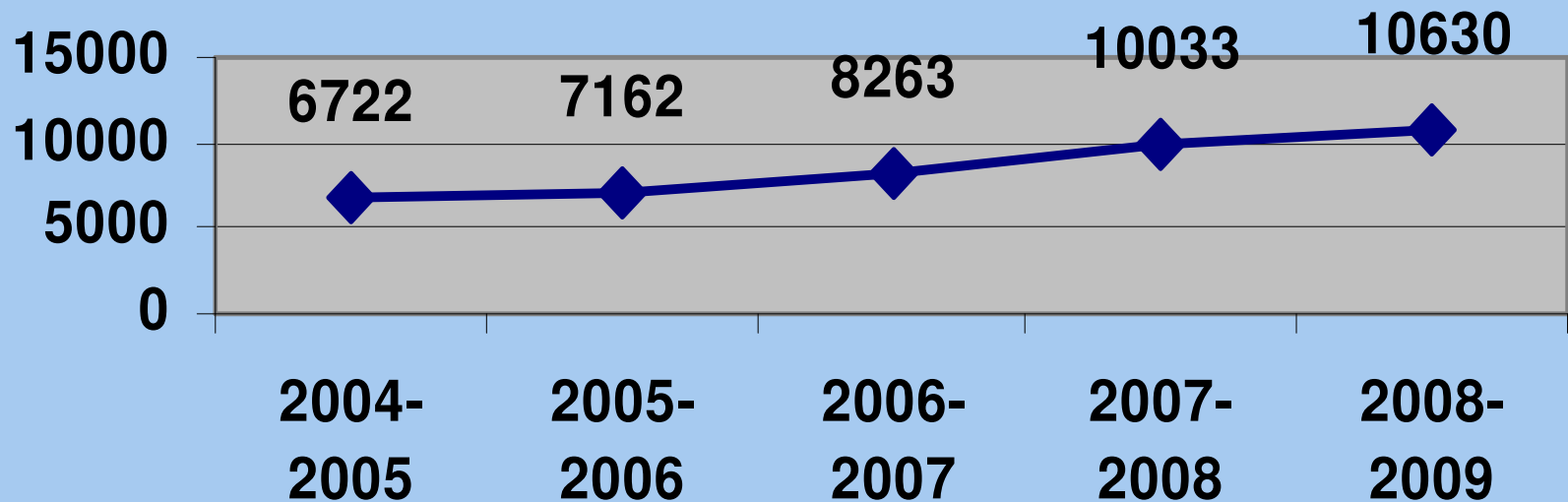
Superior Criminal Caseload Inventory Felonies

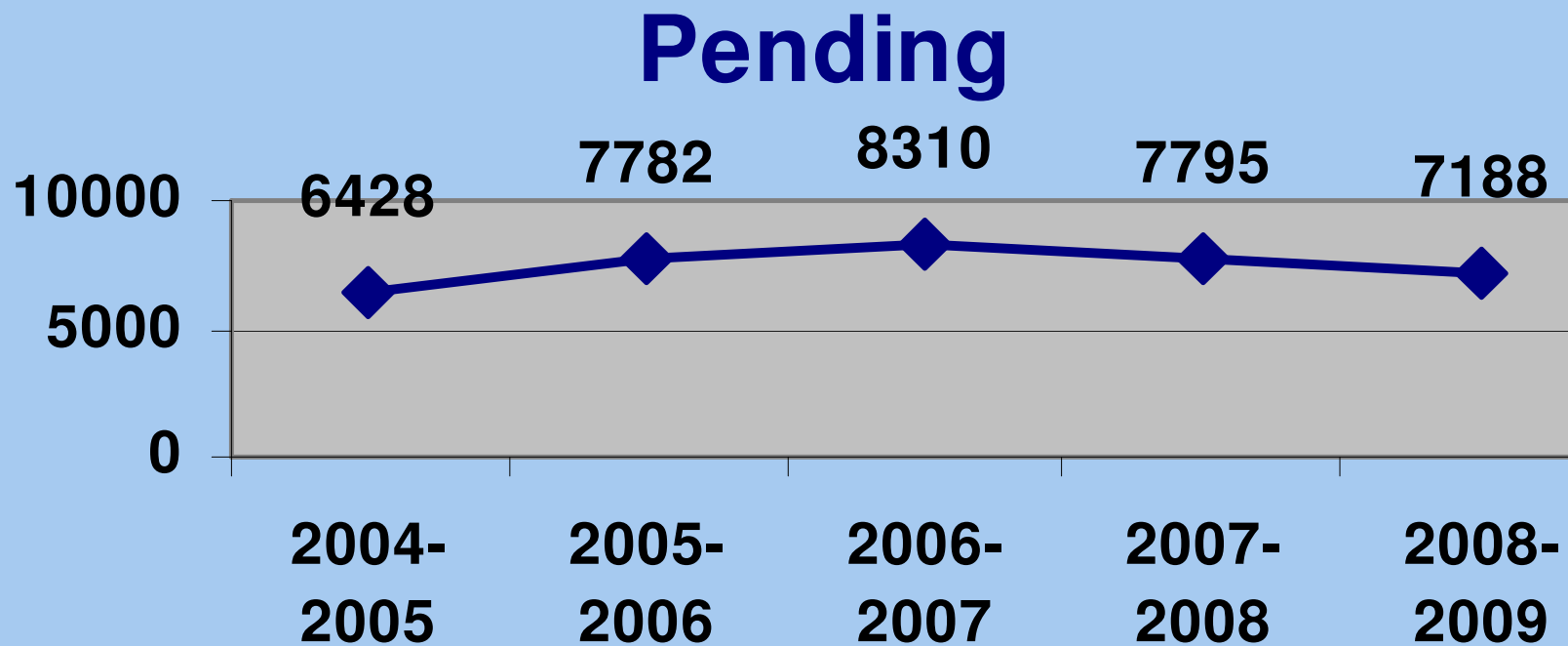


Superior Criminal Caseload Inventory-Felonies

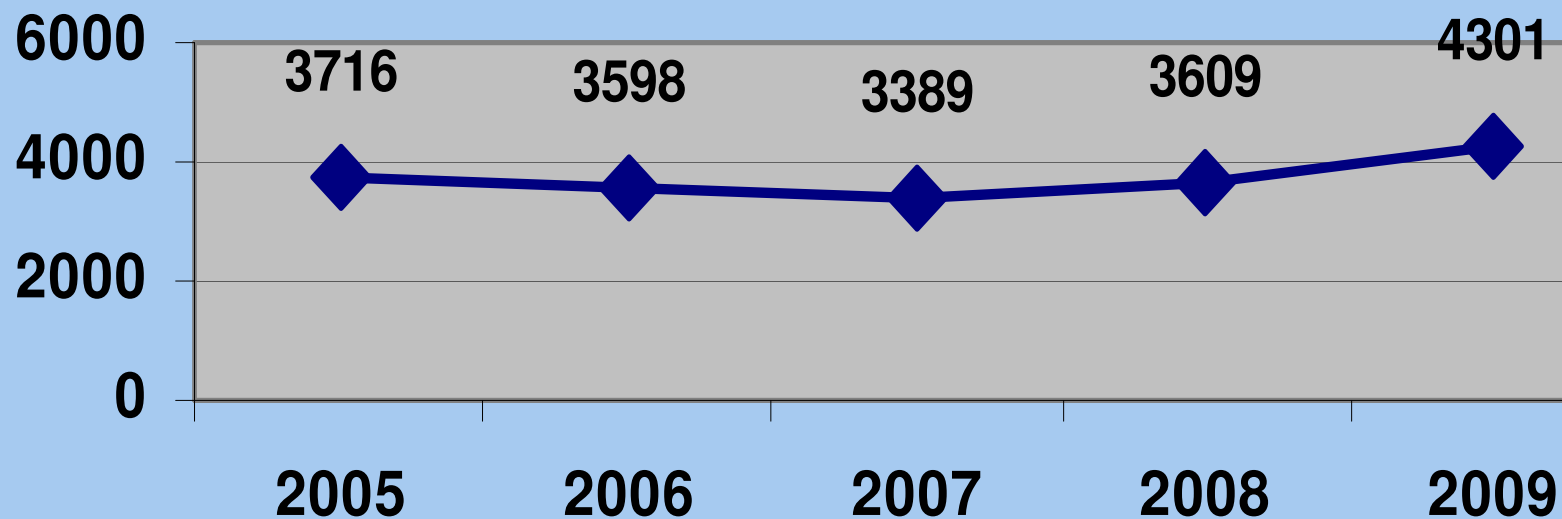


Superior Court Criminal Caseload Inventory-Felonies



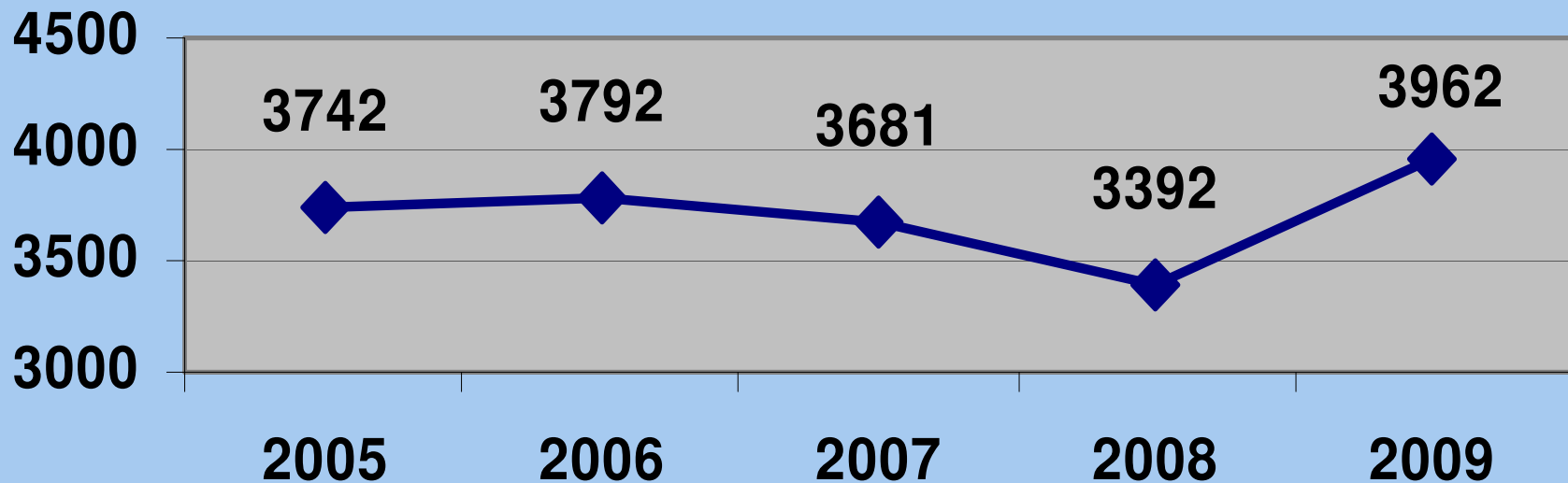

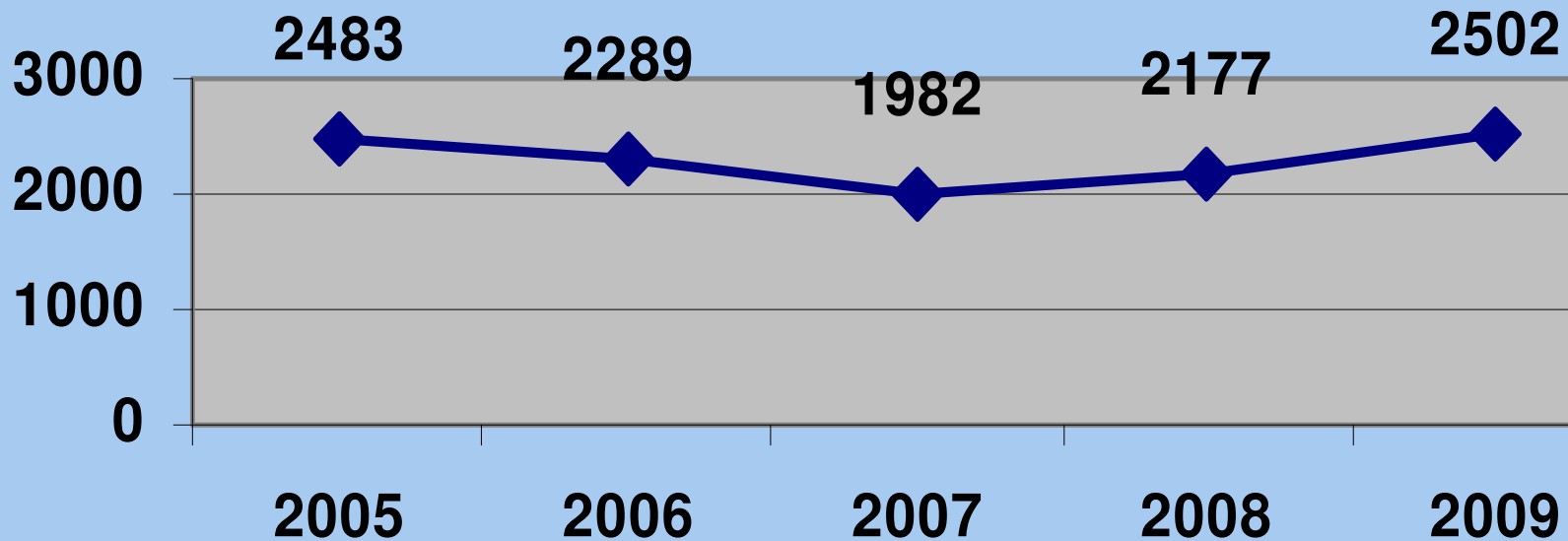

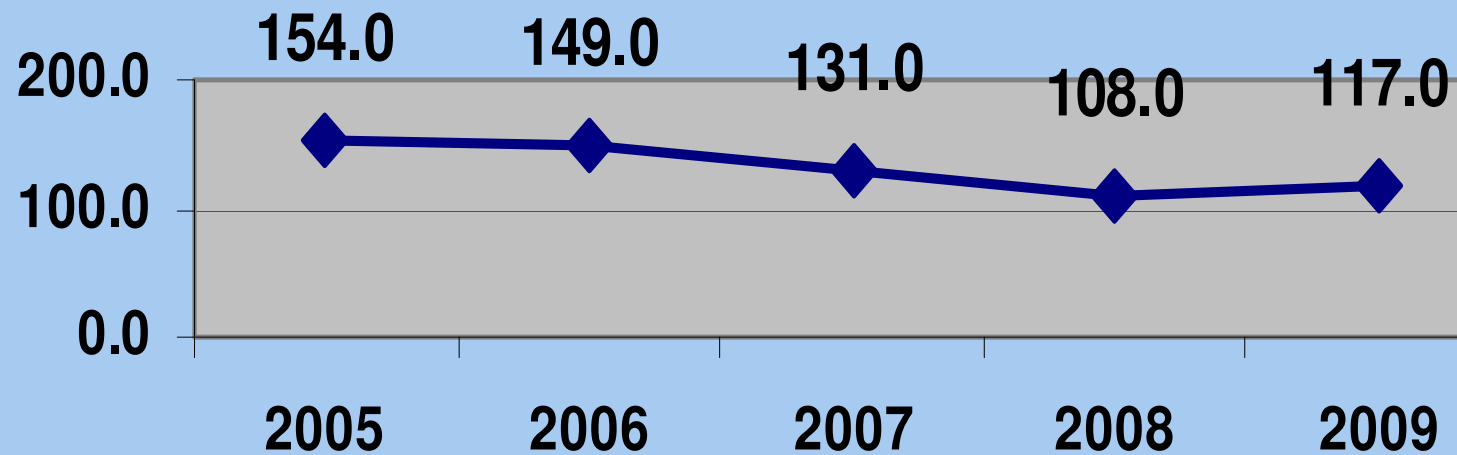

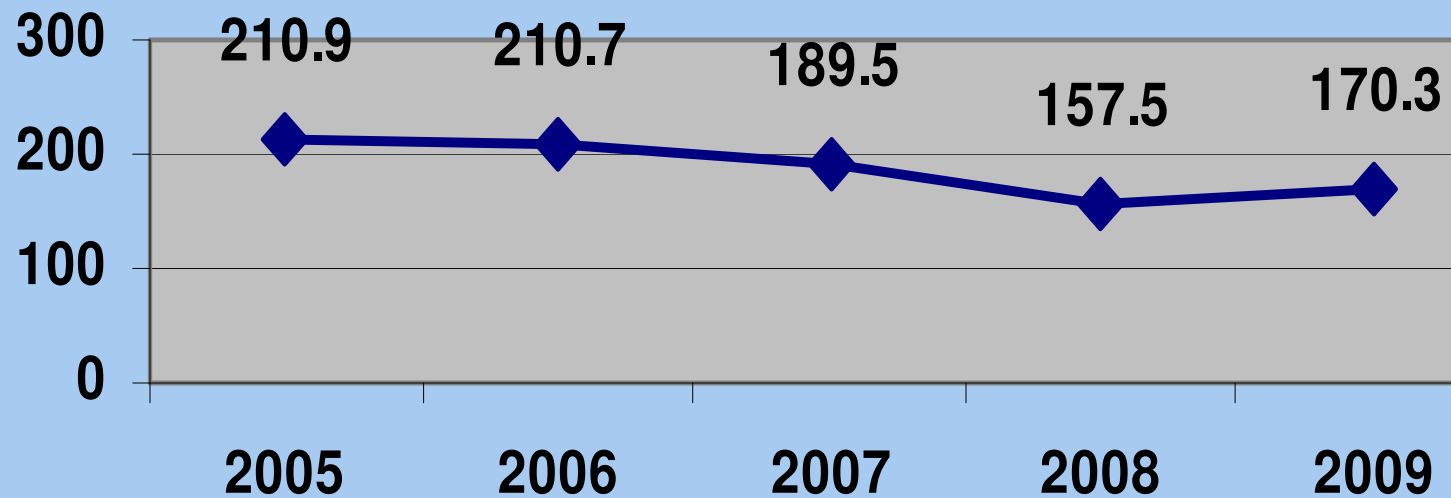

Median Age of Pending Caseload

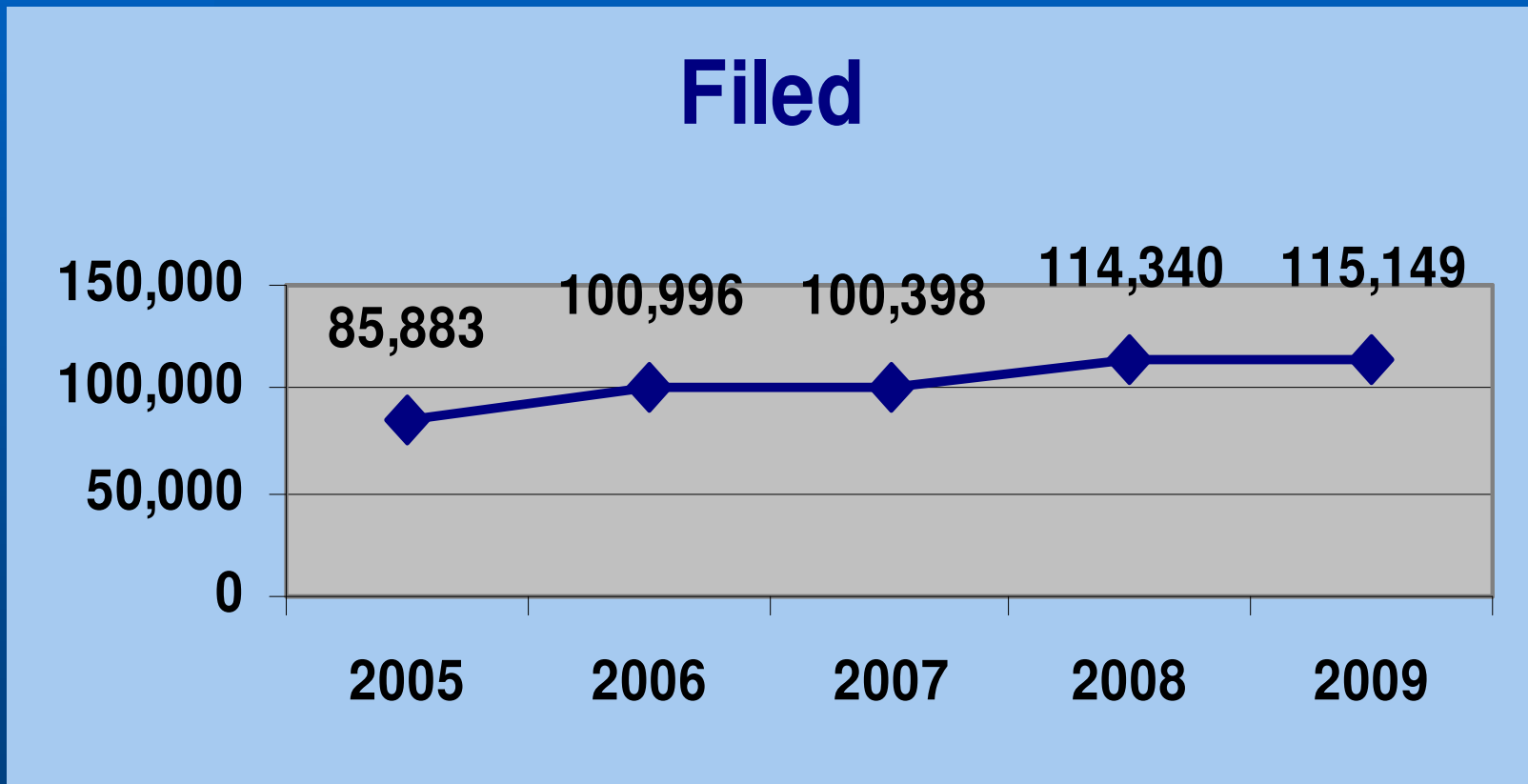

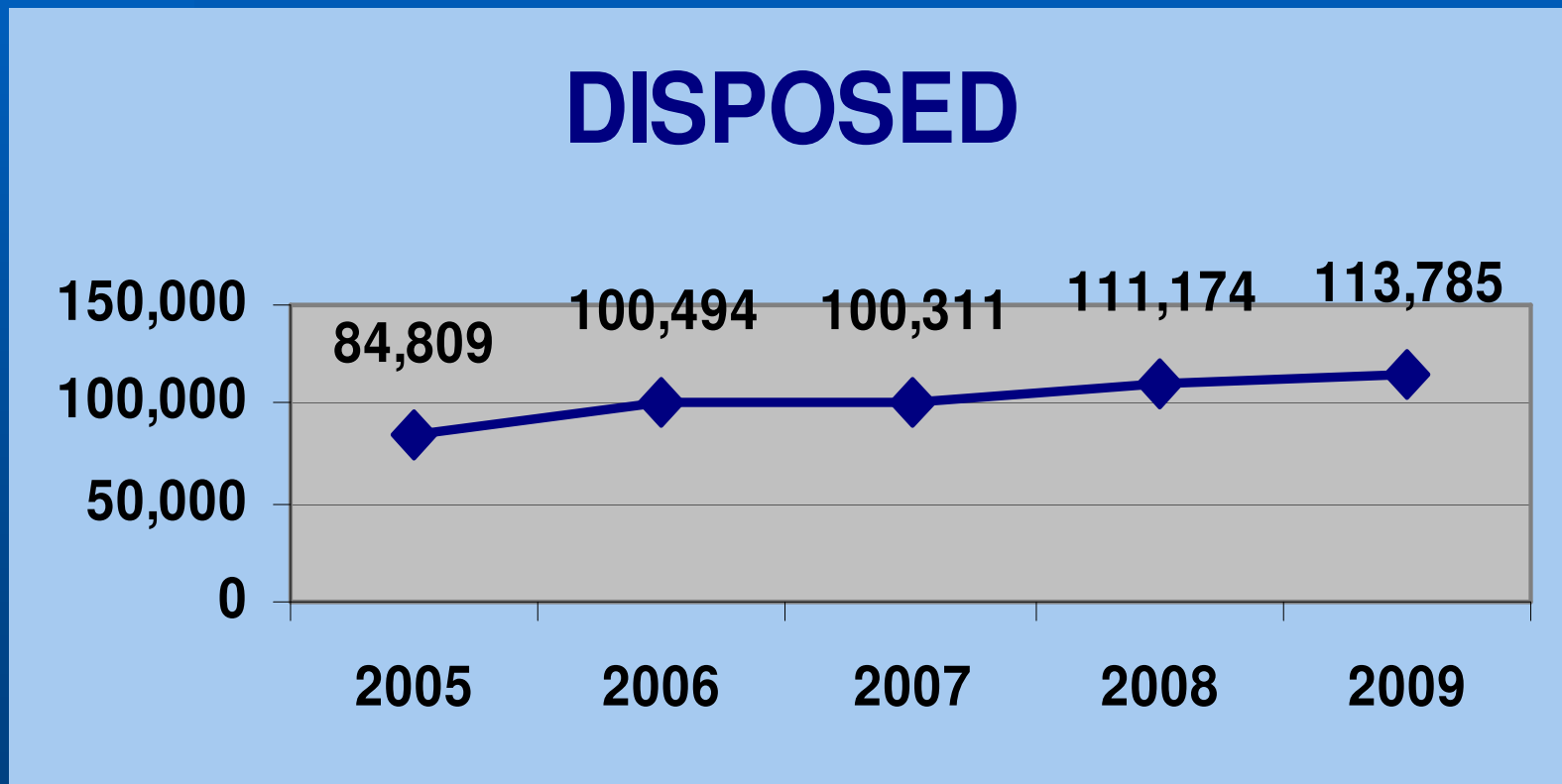
Average Age of Pending Caseload

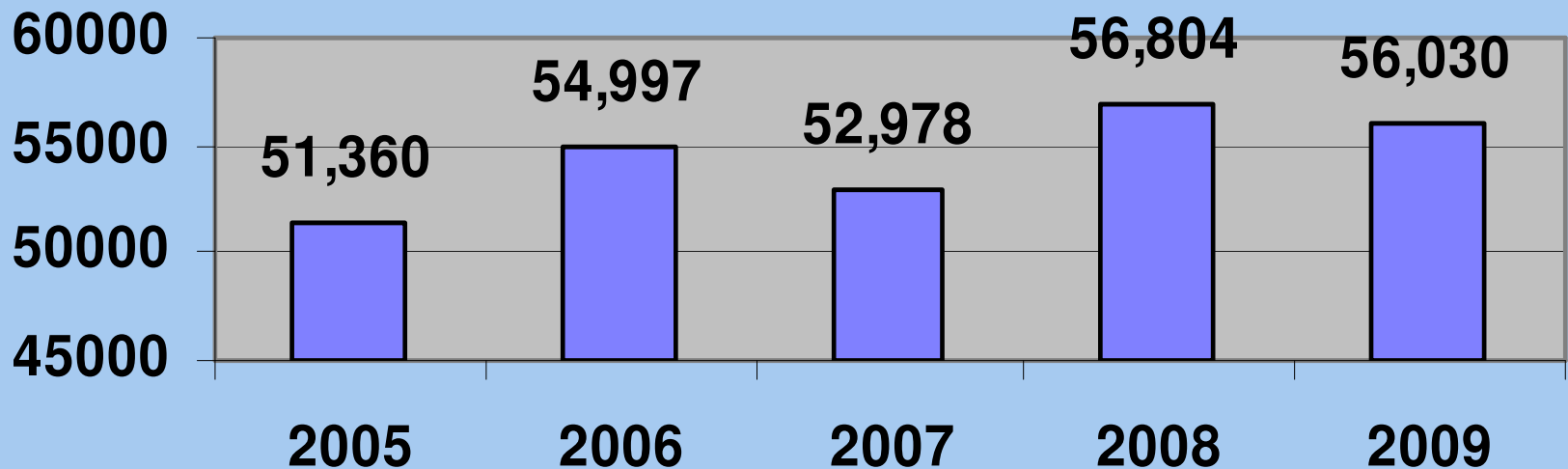

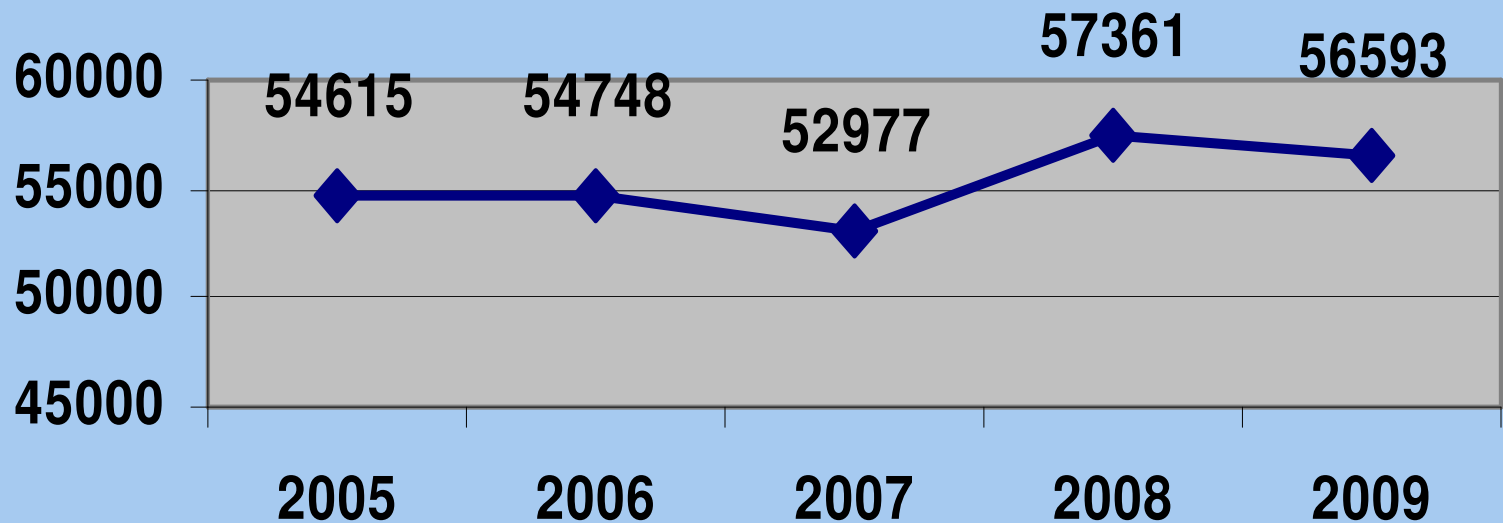

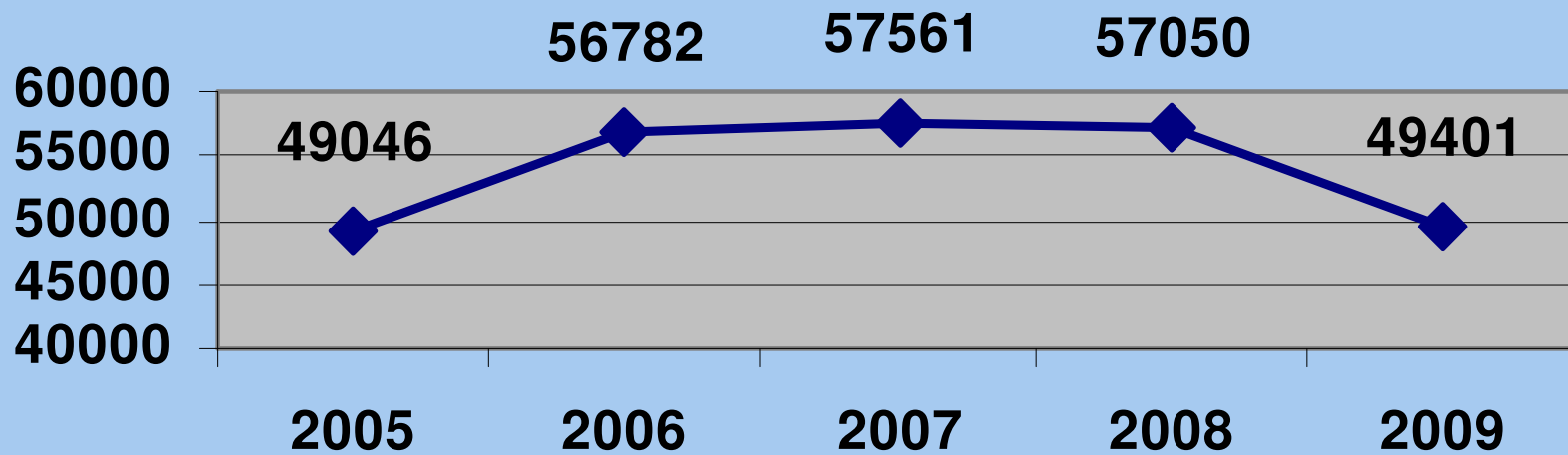

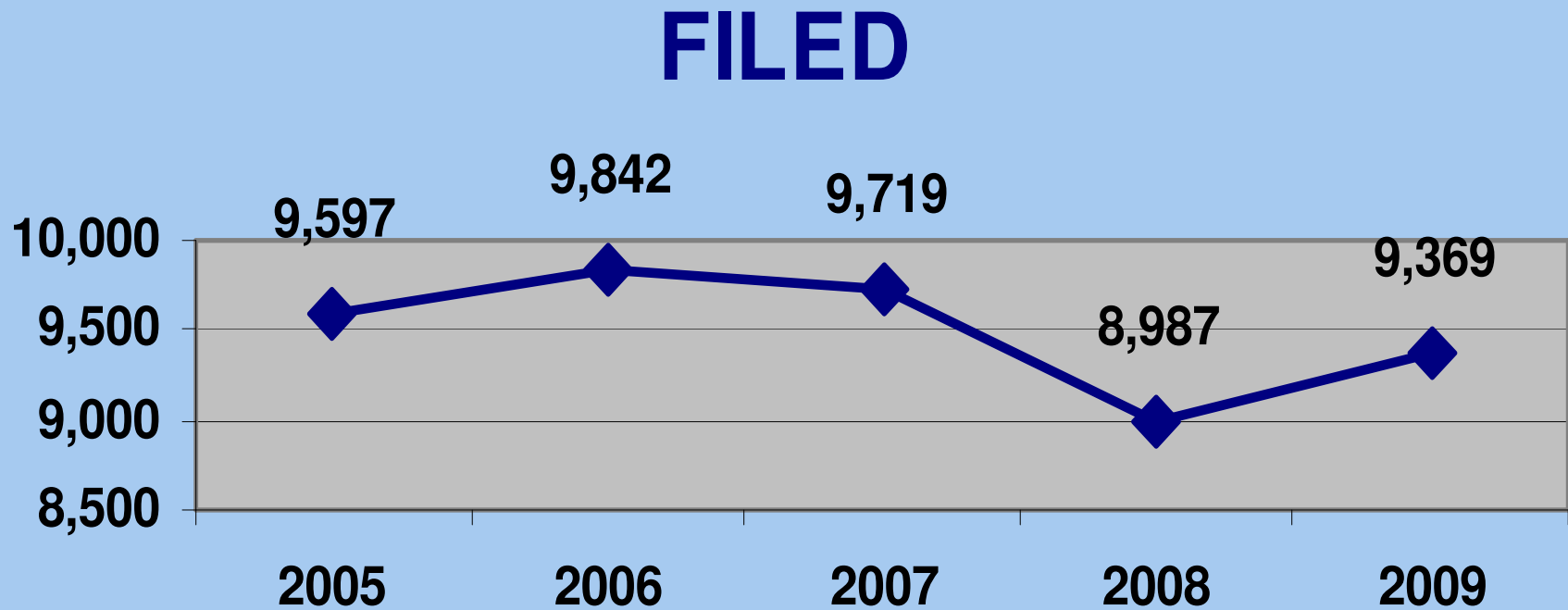

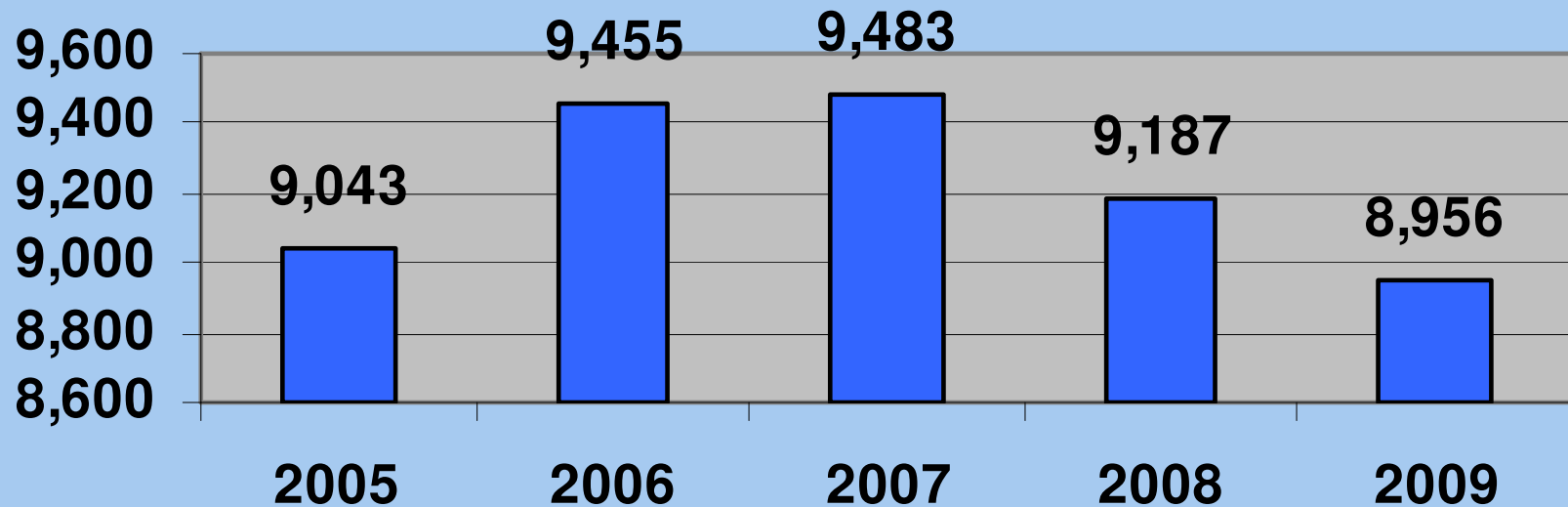

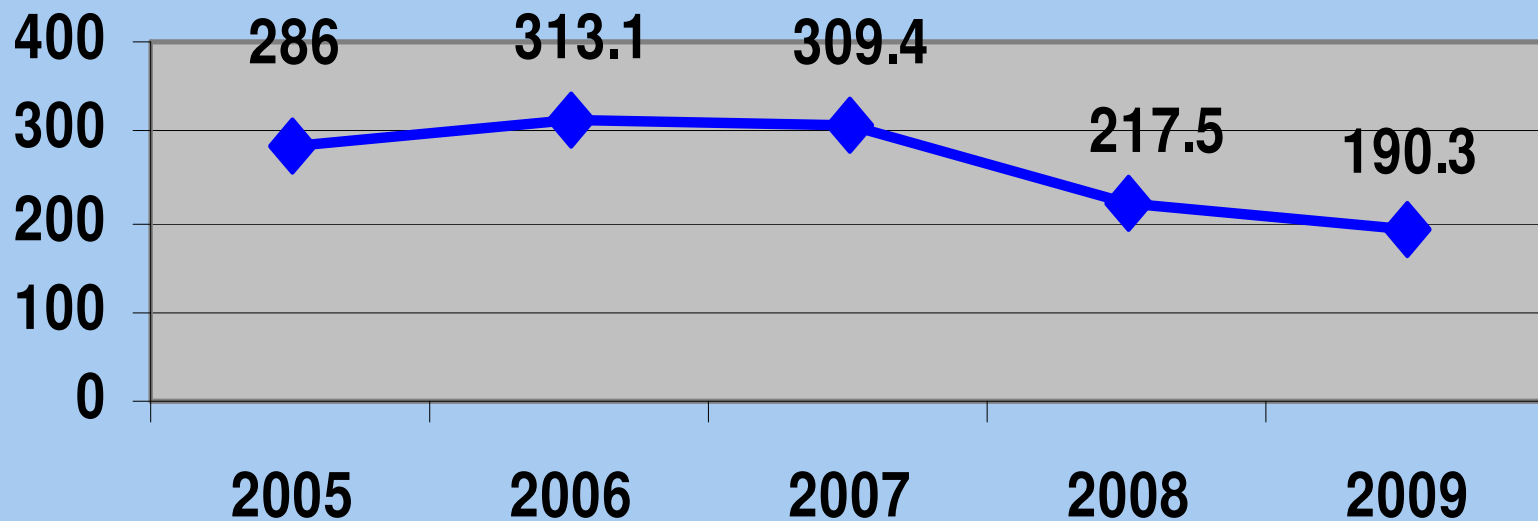

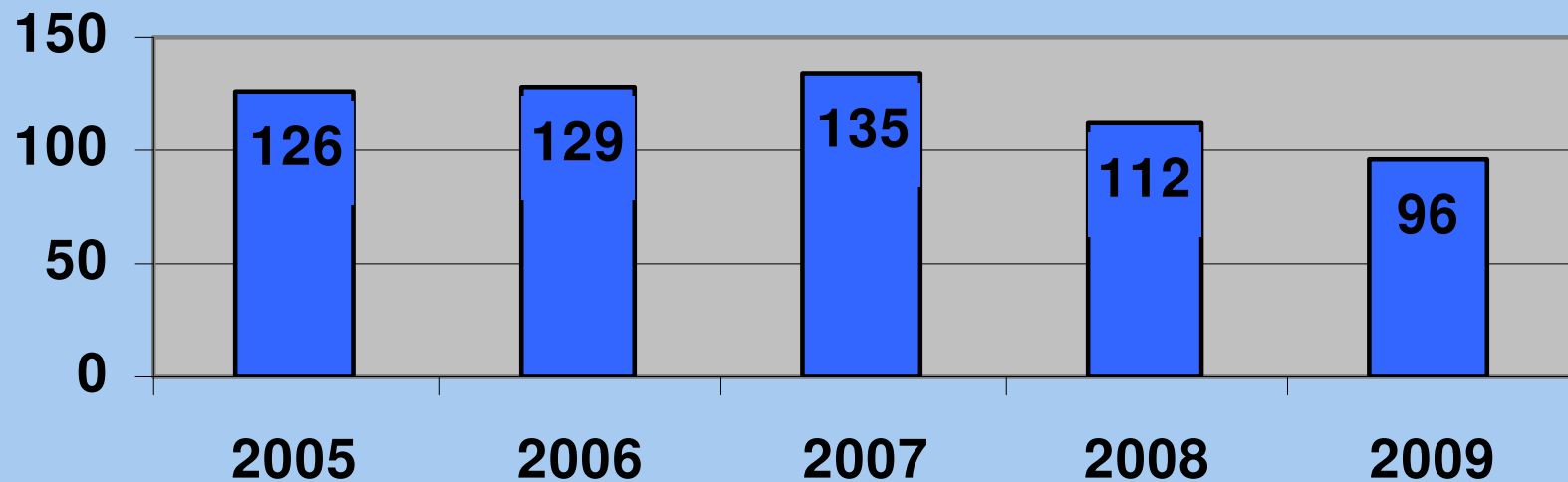
Civil Domestic Relations
