District Attorney Candidate's Debate - Justice Initiatives, Inc. was proud to sponsor a debate between candidates for the office of District Attorney on Thursday, October 14th at The Charlotte School of Law. The public was invited to meet Michael Barnes (Democrat) and Andrew Murray (Republican) to learn more about their positions concerning the administration of criminal justice in



Mecklenburg County. Julie Rose, WFAE 90.7 Reporter, moderated the event. The candidates addressed questions posed to them by audience members and a three-member panel composed of: Carolyn Greene-Logan, Mecklenburg County Criminal Justice Advisory Committee; Anita Blowers, Associate Professor, UNC-Charlotte Department of Criminal Justice and Criminology; and, Billy Wilson, Justice Initiatives Board Member.

Judicial Candidate's Forum - Justice Initiatives, Inc. proudly sponsored a judicial candidate's forum for all individuals vying for seats on the District Court Bench and Superior Court Bench in Mecklenburg County. The



forum took place on Thursday, October 21, 2010, at the Charlotte School of Law. Taylor Batten, The Charlotte Observer Editorial Page Editor, served as moderator for the event. Eleven candidates addressed questions from Taylor and the audience members. The format also allowed for the candidates to ask questions of each other, which led to

## **Other Fall Events**

#### Justice Initiatives hosts the Fall 2010 Courts & **Media Seminar**

Justice Initiatives, Inc., in partnership with The Trial Court Administrator's Office, held the Fall 2010 Courts and the Media Seminar on Wednesday, October 20. The purpose of what has become a semi-annual seminar is to foster a stronger relationship between the Mecklenburg County Courts and members of the local media, as well as educate the media about the courts, court procedures, and operational protocol. The seminar also serves as a means to educate judges and court officials about the media and allows for open discussion in a non-adversarial setting. The event focused on the foreclosure process and procedures in North Carolina in addition to Small Claims Court. Assistant Clerk of Superior Court Cameron Scott spoke to members of the media on foreclosures. Civil Magistrate Deborah Pope discussed the Magistrate's role in the judicial system and gave an overview of Small Claims Court.

Each year, on the Saturday before Thanksgiving, the National Adoption Day Coalition sponsors National Adoption Day to raise awareness of the need to find permanent, loving homes for the thousands of children in foster care currently available for adoption and to insure that post-adoption services are available to fami-

Justice Initiatives Inc., along with the Mecklenburg County Juvenile Court, the Mecklenburg County Clerk of Superior Court's Office, the Mecklenburg County (DSS), and the Guardian Ad Litem program, cosponsored the seventh-annual National Adoption Day. The court session was presided over by Chief District Court Judge Lisa C. Bell and was part of a larger event that took place at the courthouse that included games and activities for children. Representatives from various adoption agencies were also on hand to answer questions regarding adoption.
